उपसा केला जातो. अधिकृत वाळू उपसा हात असलेल्या ठिकाणावरून दिवसाकाठी शंभरच्या जवळपास ट्रक दिवसाकाठी वाहतूक करतात. मात्र जे वाळू पट्टे प्रशासनाच्या म्हणण्यानुसार बंद आहेत तेथून दिवसाकाठी ५० ते ६० ट्रक अवैध वाळूची तस्कराी होत आहे.
