Sub: Consolidated Scrutinizer's Report for passing of Resolutions through E-Voting Process and Voting by Poll at 22nd Annual General Meeting (AGM) of the Members of Yuvraaj Hygiene Products Limited (the Company) held on Tuesday, 26th September, 2017.

- We, M/s. Manish Ghia & Associates, Company Secretaries, Mumbai were appointed as Scrutinizer by the Board of Directors of the Company for the purpose of:
 - Conducting Poll through polling papers under the provisions of Section 109 of the Companies Act, 2013 read with Rule 21 of the Companies (Management and Administration) Rules, 2014;
 - b) Scrutinizing the e-voting process in terms of the provisions of Section 108 of the Companies Act, 2013 ('the Act') read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended from time to time and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015;
 - c) Scrutinizing the votes cast through Polling Paper (at the AGM) for those shareholders, who do not access to e-voting facility.

in a fair and transparent manner, for passing of the Resolutions as mentioned under item numbers 1 to 5 as set out in the Notice of 22nd Annual General Meeting (AGM) of the members of the Company dated 22nd August, 2017.

2. The management of the Company is responsible to ensure the compliances with the requirements of the Companies Act, 2013 and Rules relating to e-voting and voting by polling papers at AGM on the resolutions contained in the Notice of AGM of the members of the Company. Our responsibility as a Scrutinizer for the e-voting process and poll conducted at the AGM is restricted to make a Consolidated Scrutinizer's Report of the votes cast 'in favour' or 'against' the resolutions stated in the said Notice,

based on the reports generated from the e-voting system provided by Central Depository Services (India) Limited ("CDSL"), the agency engaged by the Company to provide e-voting facility, and poll conducted at the AGM in a fair and transparent manner.

- 3. As per the confirmation received from the Company:
 - a. The Notice of the AGM dated 22nd August, 2017 was dispatched by courier to the shareholders at their registered addresses on Friday, 1st September, 2017 and by email on Monday, 4th September, 2017 to those shareholders, whose e-mail id is registered with the Registrar and Share Transfer Agent / Company / Depositories.
 - b. The said Notice was dispatched on the basis of Register of Members made available by M/s. CIL Securities Limited, the Registrar and Share Transfer Agent of the Company and the list of beneficial owners made available by the depositories viz., National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL) as on Friday, 25th August, 2017.
- 4. As per the provisions of Rule 20 of the Companies (Management and Administration) Amendment Rules, 2016, as amended from time to time, the Company has published advertisement about completion of dispatch of Notice of meeting and providing evoting facility in the English newspaper "Business Standards" and Marathi newspaper "Jan Shakti" on Monday, 4th September, 2017.
- In terms of the aforesaid Notice, voting through electronic means was kept open for 3
 (Three) days from Saturday, 23rd September, 2017 (9.00 a.m. IST) till Monday, 25th
 September, 2017 (5.00 p.m. IST).
- The voting rights of members was considered in proportion to the shares held by them
 in the paid up equity share capital of the Company as on the cut-off date i.e. Tuesday,
 19th September, 2017.
- 7. As required under the said rules, after the closure of physical voting by Polling Papers at the AGM, the votes cast through Poll were counted; thereafter the votes cast under the e-voting facility were unblocked in the presence of CS Rasika Mendhekar and CS Khyati Shah who are not in employment with the Company.
- The poll papers which were incomplete and/or found defective have been treated as invalid and kept separately.
