To deal with its NPA problems, IDBI Bank has, in the past, sold its stake in the National Stock Exchange to LIC and has also sold its office building in BKC to the markets regulator for an estimated value of ₹1,000 crore.

As on September 30, 2018, IDBI Bank had gross NPAs of 32 per cent and net NPAs of 17.3 per cent.

Meanwhile, the asset management industry has been grappling with slowing equity flows and volatility in the debt markets since the IL&FS crisis in September last year. In April, the equity flows slipped to a 31-month low of ₹4,608 crore, with industry sources suggesting May to also be a tepid month for flows.

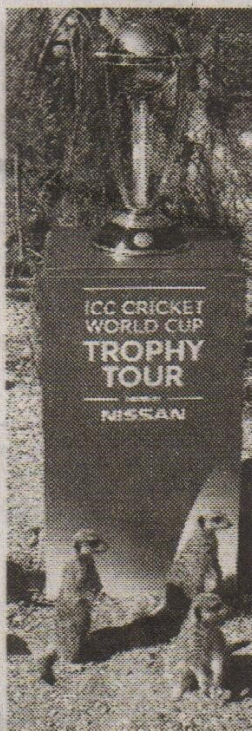
