Sub: Consolidated Scrutinizer's Report for passing of resolution through Remote E-voting and E-voting by the members during the 29th Annual General Meeting (AGM), pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 of Yuvraaj Hygiene Products Limited ('the Company') for its AGM held on Monday, September 30, 2024 at 12:00 noon (IST) through Video conferencing ('VC') / Other Audio Visual means ('OAVM').

- 1. I, CS Mannish L. Ghia, Partner at M/s. Manish Ghia & Associates, Company Secretaries, Mumbai was appointed as Scrutinizer by the Board of Directors of the Company for the purpose of scrutinizing the process of voting through electronic means ("e-voting") in terms of the provisions of Section 108 of the Companies Act, 2013 ('the Act') read with Rule 20 of the Companies (Management and Administration) Rules, 2014 ('the Rules') as amended from time to time and Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 in a fair and transparent manner, for passing of the resolutions as mentioned under item numbers 1 and 2 as set out in the notice of AGM dated September 02, 2024 ("Notice") issued by the Company in accordance with Circulars dated December 28, 2022, read together with Circulars dated April 08, 2020, April 13, 2020, May 05, 2020, January 13, 2021, December 08, 2021, December 14, 2021, May 05, 2022 and September 25, 2023 (collectively referred to as "MCA Circulars") and Circular No. SEBI/HO/CFD/PoD-2/P/CIR/2023/4 dated January 5, 2023 issued by Securities and Exchange Board of India ("SEBI"), for convening the 29th AGM of its members through VC / OAVM held on Monday, September 30, 2024 at 12:00 noon IST. After ascertaining the requisite quorum, the meeting commenced at 12:05 p.m. IST as some of the directors were facing technical difficulties in commencing the meeting.
- 2. The management of the Company is responsible to ensure the compliances with the requirements of the Companies Act, 2013, the Rules, MCA Circulars and SEBI Circulars relating to remote e-voting and e-voting during the AGM on the resolution contained in the aforesaid Notice of AGM of the members of the Company. My responsibility as a Scrutinizer for the e-voting process is restricted to make a Consolidated Scrutinizer's Report of the votes cast 'in favour' or 'against' the resolution stated in the said Notice, based on the reports generated from the e-voting system provided by Central Depository Services (India) Limited ("CDSL"), the agency engaged by the Company to provide E-voting facility, and that the e-voting is conducted in a fair and transparent manner.
- 3. As per the confirmation received from the Company:

a. The Notice of the AGM along with Statement setting out material facts under Section 102 of the was sent by e-mail on Friday, September 06, 2024 to those shareholders, whose e-mail id is

- registered with the Registrar and Share Transfer Agent / Company / Depositories on Friday, August 30, 2024 as per MCA and SEBI Circular.
- b. The said notice was sent on the basis of Register of Members made available by M/s. CIL Securities Limited, the Registrar and Share transfer agents of the Company and the list of beneficial owners made available by the depositories viz, National Securities Depository Limited (NSDL) and Central Depository Services Limited (CDSL) as on Friday, August 30, 2024.
- 4. As per the provisions of MCA General Circular No. 20/2020 dated 05<sup>th</sup> May, 2020, the Company has published advertisements in the "Business Standard (English Edition)" and "the Pratahkal (Marathi Edition)" on Wednesday, September 04, 2024 regarding compliance with the said circular in relation to 29<sup>th</sup> Annual General Meeting of the Company.
- 5. As per the provisions of Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 30 and 47 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company has published advertisements in "Business Standard (English Edition)" and "the Pratahkal (Marathi Edition) on Saturday, September 07, 2024 regarding completion of dispatch of Notice of meeting through email and providing e-voting facility.
- 6. In terms of the aforesaid Notice, remote e-voting period was kept open for 3 (three) days from Friday, September 27, 2024 at 9.00 a.m. (IST) till Sunday, September 29, 2024 at 5.00 p.m. (IST).
- 7. The voting rights of members was considered in proportion to the shares held by them in the paid up equity share capital of the Company as on the cut-off date i.e., Monday, September 23, 2024.
- As required under the MCA Circulars, the Company had also provided e-voting facility to the members attending the AGM through VC / OAVM and who had not cast their vote earlier.
- 9. The remote e-voting module was disabled by Central Depository Services (India) Limited ("CDSL") on Sunday, September 29, 2024 after 5:00 P.M. and as required under the said rules, the votes cast under the remote e-voting facility prior to the AGM and e-voting facility during the AGM were unblocked in the presence of CS Khushbu Shah and Mr. Suraj Upadhyay who are not in employment with the Company.
- 10. I have scrutinized and reviewed the remote e-voting and e-voting during the AGM and votes cast therein based on the data downloaded from the e-voting system of CSDL and the summary of the e-voting process is as follows:
